





I Believe in Marriage, but not for our two Judges

Our current judge is Lyndsey Brunette. Her husband, Jake Brunette is running to be the second judge in Clark County. Having two judges should make it easier for Clark County, not harder. Two judges should increase the availability of a judge when needed. Two judges can coordinate schedules so one is always available. With two judges that are not married, when one judge is on a family vacation or unavailable because of a family emergency, the other can:

- Cover the daily business of the courts without interruption, delay, or the need to bring in a judge that Clark County did not elect.
- Sign search warrants when needed, so our law enforcement officers don't have to find a judge from another county and travel for a signature, especially at 3:00 am.
- Handle hearings that by State Statute must be held within 24 or 48 hours of the event (such as juvenile or mental





health cases), without having to bring in a judge from another county.

Judges must decline to hear cases because of a conflict, such as a case involving a relative or close friend. If a married judge has a conflict, most likely the spouse does too-creating the burden and expense of a judge from another county.

Every person under Wisconsin law has a right to ask for an impartial judge to hear his or her case—a "substitution of judge." In counties with more than one judge, the case is often transferred to another judge from the same county. But when the two judges are married, it seems your right to "substitution" is now meaningless—going from husband to wife or vice versa is not really a change of judge at all.

Therefore, vote for WILLIAM BRATCHER, the INDEPENDENT CHOICE we need for our second Clark County Judge.

> This full reconstruction Highway Safety Improvement Project (HSIP) proposed work consists of reducing the profile of the County Road H east of County Road K intersection by approximately 4.5 feet, which will increase the intersection sight distance. Right turn lanes are proposed on both eastbound and westbound County H. Widening will occur on both sides of County H due to the addition of right turn lanes and the reduction of the roadway profile. AND GOD SAYS . .

Jay Sekulow, ACLJ Chief Counsel, wrote "The U.S. Postal Service (USPS) is now forcing postal workers to work on Sunday. In fact, the USPS refused to give a postal worker an accommodation to continue going to church on Sunday (which he had always done). And a federal court ruled that he has NO RIGHT to go to church."

Just think about this. We all get at least one day a week that we do not need to work. So what's the big deal if one man desires Sunday as his day off.

Delivering mail on Sunday just increases the USPS payroll budget by almost 15% and will really accomplish nothing. And remember, the USPS is already having financial troubles and has had for a long time.

Also, most financial institutions are not open on Sunday. So they neither send nor receive mail nor are there any banking transactions that take place on Sunday. So what is the purpose of mail service on Sunday?

May I suggest that maybe the motive is something entirely unrelated to profit and loss or of improving the mail service. Maybe it really has to do with something more sinister, like an attack against that which is to honor God. In the early church, Sundays began to be the day of worship in recognition of the resurrection of our Lord Jesus Christ. It became known as "the Lord's day."

But Satan's plan is to desecrate, in any way he can, anything that honors Jesus. Thus it is that Jesus name is continually used as a cuss word. When churches have been vandalized, the communion elements are crushed under foot and/or urinated on. The Bible is not allowed to be read in our schools, and prayer is attacked as improper. And for the last few decades, Sunday has been under attack more and more. Now a federal judge has ruled that business is more sacred than church and therefore the postal worker must work rather than go to church.

Well, so much for freedom of religion. We as believers must wake up to the fact that underlying all that is going on in the culture war today is a spiritual battle and we must take our stand for righteousness in fear of God rather than of men. That is real worship.


