**Ordinance #DDV- 2202  
Date Approved - Draft #1  
Animal Control Ordinance**

This ordinance is to establish the minimum requirements for animal control with exception of farm livestock.

**WHEREAS**, the Town Board of the Town of Dewhurst, Clark County, Wisconsin has the authority to regulate matters affecting the health, safety and general welfare of its residents and has adopted township power to enact this ordinance; and

**WHEREAS**, The Town deems it expedient and necessary to establish certain requirements with respect to animal control;

**NOW THEREFORE**, The Town Board of the Town of Dewhurst do ordain as follows:

**REGULATION AND LICENSING OF DOGS:  
Section 1-15**

1. **DOG LICENSE REQUIRED.** It shall be unlawful for any person in the Town of Dewhurst to own, harbor or keep any dog more than five (5) months of age without complying with the provisions of this ordinance and Wisconsin State Statute 174.10 related to listing licensing and tagging of the same.

2. **LICENSE FEE.** The license fee for a dog shall be as follows:

- A. Unneutered Male Dog      Per fee schedule
- B. Unspayed Female Dog    Per fee schedule
- C. Neutered Male Dog        Per fee schedule
- D. Spayed Female Dog        Per fee schedule

The Town Board reserves the option of adjusting the Attachment A, fee schedule.

3. **LATE FEES.** The Town Treasurer shall assess and collect a late fee per the fee schedule from every owner of a dog five (5) months of age or older if the owner failed to obtain a license prior to April 1 of each year or within 30 days of acquiring ownership of a licensable dog, or if the owner failed to obtain a license before the dog reached a licensable age.

4. **CHANGE OF OWNERSHIP.** If there is a change in ownership of a licensed dog or kennel during the license year, the owner may have the current license transferred to his/her name upon the payment of a transfer fee per the fee schedule, if applicable

5. **TRANSFER PROHIBITED.** No person shall use any animal license or rabies receipt or license or rabies tag issued for another animal.

6. **KENNEL LICENSE OPTION.** The owner of kennels may opt to pay a kennel license fee per the fee schedule in lieu of the fees provided in sub. 2 above and the Town Treasurer shall issue tags for each dog owned by the kennel owners.

Kennel operating permits shall be issued by the Town Board.

7. **RABIES VACCINATION REQUIRED.** It shall be unlawful for any person to keep a dog in the Town of Dewhurst which is over five (5) months of age and has not received a rabies vaccination as required by State Statute 95.21(2). No dog license shall be issued until a certificate of rabies vaccination issued by a licensed veterinarian has been presented. A rabies vaccination tag shall be attached to the collar of all licensed dogs at all times, except as provided in WI State Statute 95.21(2)(f).

8. **DEFINITIONS.**

A. **OWNER**-Any person owning, harboring or keeping a dog and the occupant is customarily returned daily for a period of 19 days is presumed to be harboring or keeping the dog within the meaning of this section.

B. **AT LARGE**- A dog which is off the premise of the owner and not under the control of some person either by leash or otherwise, but an animal within an automobile of any other person with the consent of the animal's owner shall be deemed to be upon the owner's premises

C. **KENNEL**-Any establishment wherein dogs are kept for the purpose of breeding, sale or for sporting purposes.

9. **RESTRICTIONS ON KEEPING DOGS.** It shall be unlawful for any person within the Town of Dewhurst to own, harbor or keep a dog which:

- A. Habitually pursues vehicles upon any street or highway
- B. Molests passerby(s) or assaults or attacks a person without provocation
- C. Is at large within the limits of the Town of Dewhurst
- D. Habitually barks or howls to the annoyance of any person or persons.
- E. Kills, wounds or harasses any domestic or wild animal.

10. **DOGS RUNNING AT LARGE AND UNTAGGED DOGS.**

A. **DOGS RUNNING AT LARGE.** A dog is considered to be running at large if it is off the premises of its owner and not under the control of the owner or some other person, as defined in sub.(8)(b).

B. **UNTAGGED DOGS.** A dog is considered to be untagged if a valid license tag is not attached to a collar which is kept on the dog whenever the dog is outdoors unless the dog is confined in a fenced area.

C. **DOGS SUBJECT TO IMPOUNDMENT.** The Clark County Sheriff or Clark County Humane Society or any peace officer shall attempt to capture and restrain any dog running at large.

D. **PENALTIES.** If the owner of a dog, negligently or otherwise, permits the dog to run at large or permits a dog to be untagged, the owner shall forfeit \$50 for the first offense and \$100 for subsequent offenses. Additionally, the owner will be charged any charges by the appointed Town of Dewhurst Chairman or his/her designee.

11. **DUTY TO REPORT ANIMAL BITE.** Every person, including the owner or person harboring or keeping a dog or other animal, who knows that such animal has bitten any person shall immediately report such a fact to the Clark County Sheriff's Department.

12. **QUARANTINE OR SACRIFICE OF ANIMALS SUSPECTED OF BITING A PERSON OR BEING INFECTED WITH RABIES.**

A. **QUARANTINE OR SACRIFICE OF ANIMAL.** The Clark County Sheriff or County Health Officer may order a dog or other animal quarantined if there is reason to believe that the animal that bit a person, is infected with rabies or has been in contact with a rabid animal. If quarantine cannot be imposed because the animal cannot be captured, the officer may kill the animal. The officer may kill the animal only as a last resort or if the owner agrees. The officer shall attempt to kill the animal in a humane manner and in a manner which avoids damage to the animal's head.

B. **QUARANTINE ORDER.** If a quarantine is ordered, the owner of the dog shall be subject to the provisions of State Statute 95.21 (5), (6) and (8).

13. **SETTING ANIMALS LOOSE AT LARGE PROHIBITED.** No person shall open any door or gate of any private premises for the purpose of setting any dog or other animal at large, except the owner of said animal. Violations will be followed up by the Clark County Sheriff.

14. **IMPOUNDING AND DISPOSITION OF DOGS.**

A. **IMPOUNDING OF DOGS.** The Clark County Sheriff or Clark County Humane Society Officer or any person restraining a dog running at large shall take such animals to the County Humane Society. The Officer shall attempt to identify the dog and notify the owner and keep a public record of all such dogs impounded.

B. **RELEASE OF DOG TO OWNER OR REPRESENTATIVE.** The Humane Society may release the dog to the owner if the

owner or representative: 1) give his name and address and copy of Driver's License 2) presents evidence the dog is licensed and vaccinated against rabies and 3) pays any dog's boarding fee(s).

C. **RELEASE OF DOG TO PERSON OTHER THAN OWNER.** If the owner of the dog is unknown or does not reclaim the dog within seven (7) days the Humane Society may release the dog to a person other than the owner if such person: 1) gives name, address and copy of Driver's License and 2) signs a statement agreeing to license the dog and have the dog vaccinated against rabies and spayed or neutered.

15. **PENALTIES.** In addition to other penalties provided in this document, Section 15 includes the following:

A. **FAILURE TO OBTAIN RABIES VACCINATION.** A dog owner who fails to have a dog vaccinated against rabies, as provided in this section, shall upon conviction, forfeit not less than \$50 nor more than \$100. Further refusal to vaccinate dogs will result in fines doubling. All court cost and legal fees will be the responsibility of said dog owner.

B. **REFUSAL TO COMPLY WITH QUARANTINE ORDER.** An owner of a dog or other animal who refuses to comply with an ordered issued under this section to deliver the animal to the Clark County Sheriff, the Clark County Humane Society or designated veterinarian, or who does not comply with the conditions of an order the animal be quarantined, shall upon conviction, forfeit no less than \$100 or more than \$500. Further refusal to quarantine will result in fines doubling. Court cost and legal fees will be the responsibility of said dog owner.

C. **COSTS ASSOCIATED WITH CAPTURING EITHER A LICENSED OR UNLICENSED DOG WHO IS RUNNING AT LARGE OR WHO HAS BECOME LOST.** The owner of any dog who is running at large or that the Sheriff or Humane Society Officer must find and retrieve shall be responsible for any costs incurred by the Town of Dewhurst for the Retrieval.

D. **PENALTIES FOR RESTRICTIONS ON KEEPING DOGS.** Pursuant to Section 9, A,B,C,D and E. First offense will be a warning issued by Clark County Sheriff, Humane Society or Town of Dewhurst Chairperson or designee. Fines - Second offense, \$250. Third offense, \$500, Fourth offense, Clark County Humane Society will be contacted to Remove said animal (s) from premises.

Chairman Hendrickson yielded the floor to Jon Trautman to present the 2021 Audit Report. Motion by Supervisor Trunkel seconded by Supervisor Zank to receive and file the audit report. Voice vote, motion carried.

Chairman Hendrickson yielded the floor to Terri Domaszek to present the 2023 budget presentation.

The board took a 10-minutes break at 8:10 pm.

**Resolution 20-7-22 APPROVING SALE OF COUNTY LAND IN THE TOWN OF MEAD** presented.

NOW, THEREFORE BE IT RESOLVED, the Clark County Board of Supervisors hereby approves surveying and offering for sale the real property set forth in Exhibit A.

BE IT FURTHER RESOLVED, upon completion of the survey, the Public Property Committee shall appraise the property, which shall include surveying and recordings costs, and shall offer the property via advertisement seeking bids with the Clark County Public Property Committee approving the sale upon terms that are in the best interests of the Clark County, including advertising for bids for the sale if no bids are received after the initial advertisement for bids.

**(AMENDED)**

BE IT FURTHER RESOLVED, ~~50% of the land sales proceeds generated from such sale shall be received into the General Fund, and the remaining 50%~~ **100%** of the proceeds shall be directed to the Clark County Forestry and Parks Department undesignated Dam Improvement fund.

BE IT FURTHER RESOLVED, that Corporation Counsel and the County Clerk are hereby authorized and directed to complete the sale upon terms that are in the best interests of Clark County.

Motion by Supervisor Boon seconded by Supervisor Wilcox to approve the resolution as presented. Supervisor Trunkel yielded the floor to Phil Strand from the Town of Mead. Phil asked the Board to consider putting 50% of

the sale proceeds into a Mead Lake Improvement fund, under the direction of Forestry & Parks. Chairman Hendrickson yielded the floor to Curtiss Lindner to answer questions. Chairman Hendrickson yielded the floor to Mary Shallow from the Town of Mead. Motion by Supervisor Sebesta seconded by Supervisor W. Rueth to amend the resolution by changing line #23 and #24 to read 100% of the proceeds shall be directed to the Clark County Forestry and Parks Department undesignated Dam Improvement fund. Roll call vote on the amendment, motion carried. 14 yes, 10 no and 5 absent. Voting no were Supervisors Wilcox, Zank, Kodl, Jalling, Krempasky, Hendrickson, Smagacz, Boon, Gerhardt and Bakker. **Resolution 36-10-22 APPROVING 2023 COUNTY AID FOR BRIDGE AND CULVERT CONSTRUCTION** presented.

BE IT FURTHER RESOLVED, provisions for this levy shall be made in the 2023 Clark County budget, but that this levy shall not be duplicated.

**Resolution 38-10-22 APPROVING TRANSFER OF BROADBAND ASSETS TO MOSAIC TECHNOLOGIES** presented.

NOW THEREFORE BE IT RESOLVED, that the County does hereby commit to transfer all assets deployed in conjunction with a successful Reconnect Round 4 Grant application to Mosaic upon conclusion of the grant's associated period of performance, and resulting deployment of the associated broadband network.

BE IT FURTHER RESOLVED, that within 180 days from the date of the County's acceptance of a Reconnect Round 4 Grant award the County and Mosaic shall formulate an executable agreement memorializing the terms of such an asset transfer whose terms shall be in compliance with Reconnect Program rules and regulations.

Motion by Supervisor Zank seconded by Supervisor Krempasky to approve the

resolution as presented. Chairman Hendrickson yielded the floor to Mitch Weber to explain the resolution and answer questions. Roll call vote, motion carried. 23 yes, 1 no and 5 absent. Voting no was Supervisor Kodl. Absent were Supervisors Molitor, Schindler, Klabon, C. Rueth and Haselow.

**Resolution 39-10-22 APPROVING COMMITMENT TO COMPLY WITH NET NEUTRALITY** substitute resolution presented.

NOW THEREFORE BE IT RESOLVED, upon receiving notification of RUS approval of funding via the ReConnect Program, the County will ensure that any networks operated by either the County or by Mosaic, under any contract between the County and Mosaic for the expansion of broadband service within the County, shall not:

1. Block lawful content, applications, services, or non-harmful devices, subject to reasonable network management;
2. Impair or degrade lawful internet traffic on the basis of internet content, application, or service, or use of a non-harmful device, subject to reasonable network management; and
3. Engage in paid prioritization, meaning the management of a broadband provider's network to favor some traffic over other traffic directly or indirectly, including through use of techniques such as traffic shaping, prioritization, resource reservation, or other forms of preferential traffic management, either (a) in exchange for consideration (monetary or otherwise) from a third party, or (b) to benefit an affiliated entity.

Motion by Supervisor Smagacz seconded by Supervisor Tyznik to approve the resolution as presented. Chairman Hendrickson yielded the floor to Mitch Weber to explain the resolution and answer questions. Roll call vote, motion carried. 23 yes, 1 no and 5 absent. Voting no was Supervisor Kodl. **Ordinance 241-10-22 APPROVING CREATION OF THE CLARK COUNTY HOUSING COALITION** presented.

NOW, THEREFORE BE IT ORDAINED, the Clark County Board of Supervisors does hereby approve the creation of the Clark County Housing Coalition.

BE IT FURTHER ORDAINED, the Clark County Governing Bodies – Rules shall be amended to include the information set forth:

The Clark County Housing Coalition (CCHC) Board

- a. The CCHC board shall consist of not more than 9 members. At least three members shall be persons who are elected board members. One Board member from Community Services Board; one member from Social Services Board; one member from Executive Committee. The remainder of the board shall consist of 5 6 stakeholder members with direct interest.
- b. The committee shall have charge, supervision and policy oversight of the CCHC
- c. The CCHC shall report to the executive committee.

BE IT FURTHER ORDAINED, the CCHC shall do all of the following:

- 1) Critically evaluate housing models to determine effective strategies for implementation for housing stabilization.
- 2) Collect and analyze data in order to proactively identify what factors are instability in housing and to determine more effective strategies to deploy resources.
- 3) Provide recommendations to the Clark County Board of Supervisors (County Board) and other governing bodies regarding funding sources for housing options and identify programs or services where greater cost-effectiveness and efficiencies could be achieved.
- 4) Explore, identify, and actively pursue funding options and criteria for the development and implementation of housing or services.
- 5) Engage in other activities consistent with the responsibilities of the CCHC.
- 6) Upon request, submit a report to the County Board on the CCHC's work.
- 7) Create subcommittees as deemed necessary and to engage other stakeholders and members of the public to participate in subcommittee activities.

Motion by Supervisor Zank seconded by Supervisor Krause to approve the ordinance as presented. Supervisor Waichulis yielded the floor to Lynne McDonald, ADRC Director to explain the resolution. Motion by Supervisor Kodl seconded by Supervisor Bakker to amend line #27 by changing 5 stakeholders to 6 stakeholders. Voice vote on the amendment, motion

carried. Supervisor Gerhardt yielded the floor to Judy Morrow. Judy spoke in favor of the ordinance and how good it is for everyone to come together on this issue.
